Esper Orders Pentagon into Stricter Health-Related Lockdown

Defense Secretary Mark Esper on Monday upgraded the Pentagon's [health protection level](#) to indicate substantial risk and sustained community transmission of the coronavirus, a move that places even stricter restrictions on Pentagon access.

The decision was previously reported by *Defense One*.

Most of the military installations in the Washington, D.C., area have already been designated HPCON-C, the Pentagon's second-highest level. HPCON-C coincides with the Center for Disease Control and Prevention's [Level 3 warnings](#) of sustained community transmission. The highest, HPCON-D, indicates severe risk and widespread community transmission.

Although the Pentagon has already sought to minimize staffing of the building, moving many employees to telework and practicing social distancing even in senior-level meetings, a move to HPCON-C further [lock downs](#) access to the building to non-essential personnel. Officials could also institute some medical screening practices, such as taking temperatures of employees before they enter, according to Esper.

PDI 2020 Update on COVID-19 (As of 24 March 2020)

ASMC continues to cautiously plan for the conduct of ASMC National PDI as scheduled from 27-29 May 2020. Most of the DoD and USCG financial management workforces (as well as those of our ASMC Corporate Members) are out on telework status as our nation continues to drive social distancing practices necessary to overcome this extremely critical situation. We continue to closely monitor the COVID-19 infection status related to whether the extraordinary actions being taken by our federal, state, and local governments; private sector companies; hospitals; etc, will improve the situation to the extent that travel and group gathering restrictions are lifted and PDI registrants feel safe in traveling and participating in PDI 2020.

Approximately 1300 individuals have registered and reserved their hotel room for this valuable annual training event. By mid to late April, we should know whether the crisis will be sufficiently under control to be able to safely conduct National PDI. Again, should the crisis continue, such that we need to cancel PDI, ASMC will fully refund all registration and housing fees paid, with no penalty.

We appreciate your loyalty and support, and are doing all we can to continue to move this outstanding program forward, should this extremely critical situation be reversed and our nation returns to safe status related to gathering of groups to take advantage of valuable training and professional development activities.

This fear was leading him to believe it may be best to just cash out his 401K to pay off his home and call it a day before he feared of losing it all. So he asked me if this was a good option. In my opinion, this fearful action would be investment suicide to consider such a thing with the market where it is at. Therefore, I presented him the following data/considerations and after doing so, posed the question back to him:

- a) Say your mortgage is at a fixed 4% rate and you have maybe 10 years left to pay off your mortgage.
- b) In the last month, your 401K is down over 25-30%, roughly.
- c) This virus, in my opinion, will be overcome within the next 2-3 months, maybe 6 months as the worst case scenario.
- d) So you would rather cash out of a 401K having lost 25%-30% in the last month to save you a 4% annual yield rather than continue paying your 4% mortgage and most likely gain back what you lost and then some within your 401K in the coming months as we overcome this economic downturn?

Sometimes laying out the numbers shows that we all act poorly when faced with fear and sometimes we need to step back and reassess our situation. Lastly, for us investors with a long-term mindset, I remind you of what the great Warren Buffett advises, "Be Fearful when others are Greedy and Be Greedy when others are Fearful."

I hope the best for each of you in the coming months and before you know it our Chapter will be back up and running stronger than ever! Until then, take advantage of the added time you have while teleworking by seeking continuing education credit and enhancing your knowledge. Also, take time with your families at home and be active in the yard and play games. Lastly, refrain from making any fearful drastic investment decisions during times of uncertainty and rather consult with an investment professional or relook your long-term strategy. "There is no intent whatsoever to limit the access to the press and we want to keep the building open for essential personnel and the media," he said.

The decision to upgrade the Pentagon's health-protection level comes just days after the Defense Department reported its first death from COVID-19, the disease caused by the novel coronavirus — and as President Trump has begun to publicly hint that he would move soon to loosen federal guidance keeping Americans in their homes and away from their jobs.

"WE CANNOT LET THE CURE BE WORSE THAN THE PROBLEM ITSELF. AT THE END OF THE 15 DAY PERIOD, WE WILL MAKE A DECISION AS TO WHICH WAY WE WANT TO GO!" he [tweeted](#) Monday morning.

Two people who have tested positive for COVID-19 are connected to the Pentagon. A Defense Department contractor who works in the Pentagon has been at home isolating since Mar. 7 and has not been in the building since Mar. 2. Separately, an Air Force service member visited the Pentagon for less than an hour on Mar. 16. Both are in isolation and receiving treatment.
