Shelter House, Inc. is a non-profit 501 (c)(3) organization (Federal ID# 59-2634092) and provides services to victims of domestic violence in Okaloosa and Walton Counties. Shelter House provides confidential emergency shelter, 24-hour crisis hotline, counseling and support groups, advocacy, referrals, community education, prevention and outreach services. These services are provided free of charge to the victims.

Each year, Shelter House provides approximately 5,746 days of emergency shelter to about 240 women and children, outreach services to over 250 individuals, and the 24-hour hotline receives approximately 900 calls. Without these much needed services, victims of domestic violence would have no choice but to remain with their abuser and be subjected to further abuse or become homeless.

Did you know the first National Professional Development Institute training event was held May 1977 at Williamsburg VA? And did you know, ASMC was established as the Society of Military Accountants and Statisticians in 1948 in San Antonio, TX, and was open only to active duty officers? In May 1955, it was renamed American Society of Military Comptrollers (www.asmc-lol.org/hisAnnualHistory97-98.doc). The national headquarters was opened in 1991 in Alexandria, VA, and currently serves a growing professional society of 18,000 members with 140 ASMC chapters.

When all was said and done, I was pleasantly surprised by many things to include training events offered, speakers, hotel accommodations, shuttle service, and participating vendors to name just a few.

As with any event, there will be positive and negative comments. I arrived two days early so I could participate in the Acquisition Module 4 training—yes, I passed (whew). Only two negative comments: 1) parking was not free during the two-day Module 4 training and no shuttle was available; and, 2) the internet café was not available until sometime Wednesday. In July 2006, TSgt Larkin was assigned to the HQ AFSOC staff. She's won numerous quarterly and annual awards and decorations and was selected as the ALS Leadership Award winner for her class. She's deployed twice in support of OPERATIONS ENDURING and IRAQI FREEDOM.
