## PRESIDENT'S CORNER

During the recent 2012 AETC Symposium, the Commander of AETC, General Edward A. Rice Jr., stated, "In the future we will have the resources we need to accomplish the mission. But not in the way we have in the past. And we will not have a single penny to waste."

In AETC there is a strategic imperative afoot called a "Culture of Cost Consciousness." It is precisely what Colonel Fiquett spoke about to us when he was here in August. Referred to as C3, it is being driven down from the highest general officer in AETC, to the youngest Airman and Civilian. The crux of the charge is for each member of the AETC team to save \$3.00 a day. It is expected that this could save the command as much as \$180M per year.


Our Gulf Coast ASMC chapter has membership from commands as diverse as AETC, AFMC, ACC, and AFSOC. While there are likely other representations of C3 or something like it in all of our fellow commands, the requirement for the culture to change is interesting to me. This is the first time I can remember a strategic leader prioritizing the budget as his number one concern. In fact, while General Rice was on Eglin a few weeks ago, a small group of personnel was invited to have lunch with him. The General's first question to our group was, "Have you heard of C3?" He spoke to us for an hour and spent 75% of his time on money matters.



## ***GOP endorses fed pay overhaul, smaller workforce***

### ***GOP endorses fed pay overhaul, smaller workforce***

*A draft version of the Republican Party's policy platform calls for restructuring federal pay and benefits and shrinking the government workforce. While federal workers are praised for their dedication and implementing difficult tasks, the platform says the government is too bloated and federal pay and benefits are out of whack with the private sector. It proposes cutting the federal workforce by at least 10 percent through attrition and adjusting federal compensation to reflect private sector pay and benefits.*

*The platform said the federal government has grown by at least 140,000 workers during the Obama administration and the number of employees earning at least \$150,000 has doubled. According to OPM, in September 2008, there were 1.9 million government employees, but 2.1 million in March 2012. The government workforce increased after the 9/11 terrorist attacks in part because of the creation of the Homeland Security Department.*

*The document reflects what Republican presidential hopeful Mitt Romney has said regarding the government workforce: he wants to tie the pay and benefits of federal workers to compensation packages in the private sector, which he says would save \$47 billion annually. "I don't think government workers should be paid a better deal than taxpayers who are paying for them," Romney told Fortune magazine.*

*The draft document from the GOP also called for overhauling the Postal Service, specifically mentioning the agency's underfunded pension system and the need to explore a greater role for the private sector in mail processing. In addition, the platform called the Transportation Security Administration "a massive bureaucracy of 65,000 employees who seem to be accountable to no one for the way they treat travelers" and recommended the private sector take over airport screening "wherever feasible."*
